CRIMESTOPPERS AND THE UNITED STATES MARSHAL'S ANNOUNCE **OPERATION "BOO DAT"** **IN SEARCH OF NONCOMPLAINT SEX OFFENDERS AND WANTED FELONS**

Operation "Boo Dat" is an annual fugitive round up which focuses on Sex Offenders who are noncompliant with their registry duties. The timing around Halloween is to protect families from noncompliant Sex Offenders who should NOT be participating in Halloween trick or treating activities. 24 targets are featured in Operation Boo Dat 2020 with the majority being wanted fugitive sex offenders for Failure to Register (FTR) as a Sex Offender but there are a couple of targets/fugitives wanted for charges related to felony child abuse of children and one target for open sex based offenses in Kenner, LA. Operation Boo Dat 2020 is a joint operation sponsored by the U.S. Marshals Service (USMS) Sex Offender Investigations Branch (SOIB) and USMS Eastern District of Louisiana (E/LA) New Orleans Task Force in partnership with Crimestoppers GNO, the New Orleans Police Department (NOPD), Jefferson Parish Sheriff's Office (JPSO), Orleans Parish Sheriff's Office (OPSO), and LA State Police (LSP). The operation will focus mainly on Orleans and Jefferson Parish and run from **10/19/2020-12/11/2020**.

Anyone with information on the whereabouts of these felons may contact Crimestoppers at (504) 822-1111 or online at crimestoppersgno.org and provide an anonymous tip. A reward of up to \$1,000 is available upon arrest of the wanted felon. This reward offer will expire on December 31, 2020.

1. **Ogleeliah Shadee WESTLEY** (AKA: Ogleeliah WESLEY or "Red", B/F, DOB: 01/24/1995---25 years of age, 5'06", 186 lbs. Brown Eyes and Black or Brown Hair) WESTLEY is wanted by the Jefferson Parish Sheriff's Office (JPSO) on a 11/21/2019 felony warrant for FTR as a Sex Offender. She is a Tier 3 Sex Offender convicted in LA in 2016 of Human Trafficking and Simple Kidnapping. Her last known address with JPSO SOR Unit was 4289 Lac Saint Pierre Dr. Harvey, LA. WESTLEY has ties out of state to Milwaukee, WI.
2. **Robert Paul HEIDEL Jr.** (AKA: "Bobby" W/M, DOB: 08/18/1957---63 years of age, 5'05", 150 lbs. Hazel Eyes). HEIDEL is wanted by LA State Police on a 06/30/2018, warrant for FTR as a Sex Offender. He is a Tier 3 Sex Offender convicted of Forcible Rape of a Juvenile Victim in LA in 1999. His last known address with the NOPD SOR Unit was 4339 Saint Claude Ave. New Orleans, LA.
3. **Patrick Holly JOSEPH** (B/M, DOB: 04/22/1983---37 years of age, 6'01", 205 lbs. Brown Eyes and Black Hair). JOSEPH is a Tier 1 Sex Offender convicted in LA in 2003 of Carnal Knowledge of a Juvenile. JOSEPH is wanted by the Jefferson Parish Sheriff's Office on a 04/09/2019 felony

warrant for FTR as a Sex Offender. His last known address with the JPSO SOR Unit was 317 Delegate Dr. Avondale, LA.

4. **Kevin Murray MORALES** (W/M DOB: 02/19/1973—47 years of age, 5'07", 180 lbs. Brown Eyes, Bald). MORALES is a Tier 1 Sex Offender convicted in LA in 1999 of Indecent Behavior with Juveniles. LEO records indicate that the victim was a 7 year old. He also has a prior conviction in LA for Attempted FTR as a Sex Offender. He is wanted by the Jefferson Parish Sheriff's Office on a 03/02/2020 felony warrant for FTR as a Sex Offender. MORALES last known address with the JPSO SOR Unit was Manhattan and Gretna Blvd. Harvey, LA.
5. **Leander LAFRANCE Jr.** (AKA: Lee LAFRANCE, B/M, DOB: 08/21/1974---46 years of age, 5'11", 175 lbs. Brown Eyes, Black Hair). LAFRANCE is a Tier 1 Sex Offender convicted in LA in 2012 of Carnal Knowledge of a Juvenile. LAFRANCE is wanted by the Jefferson Parish Sheriff's Office on a 03/21/2019 felony warrant for FTR as a Sex Offender. LAFRANCE last known address with the JPSO SOR Unit was 2785 Colony Ct. Marrero, LA.
6. **Clarence Lee PAYNE Sr.** (B/M, DOB: 11/25/1977—42 years of age, 5'11", 160 lbs. Brown Eyes and Black Hair). PAYNE is a Tier 3 Sex Offender convicted in LA in 2014 of Sexual Battery. LEO records indicated that the victim was a 9 year old female. PAYNE is wanted by the Jefferson Parish Sheriff's Office on a 06/27/2019 felony warrant for FTR as a Sex Offender. PAYNE's last known address with the JPSO SOR Unit was 6215 Riverside Dr. C 160 Metairie, LA.
7. **Charlie W. HILL Jr.** (B/M, DOB: 07/22/1966—54 years of age, 5'11", 190 lbs. Brown Eyes and Black Hair). HILL is a Tier 1 Sex Offender convicted in LA in 2019 of Indecent Behavior with Juveniles. HILL is wanted by the Jefferson Parish Sheriff's Office on a 01/23/2020 felony warrant for FTR as a Sex Offender. HILL's last known address with the JPSO SOR Unit was 1053 Tallow Tree Lane G Harvey, LA.
8. **Michael Wayne ALFORD** (B/M, DOB: 03/19/1963—57 years of age, 5'10", 168 lbs. Brown Eyes and Black Hair). ALFORD is a Tier 3 Sex Offender convicted in LA in 1991 of Forcible Rape. He was also previously convicted in LA in 2016 of FTR as a Sex Offender. ALFORD is currently wanted by the Jefferson Parish Sheriff's Office on a 07/23/2020 felony warrant for FTR as a Sex Offender. ALFORD's last known address with the JPSO SOR Unit was 917 S. Sibley St. Metairie, LA.
9. **Derrick Dontez LAWLESS** (B/M, DOB: 09/03/1979---41 years of age, 5'09", 190 lbs. Brown Eyes and Black Hair). LAWLESS is a Tier 2 Sex Offender convicted in LA in 2009 of Sexual Battery. LEO records indicate that the victim was a juvenile. He is wanted by the Jefferson Parish Sheriff's Office on a 01/28/2020 felony warrant for FTR as a Sex Offender. LAWLESS's last known address with the JPSO SOR Unit was 424 Meyers Blvd. Marrero, LA.
10. **Billy Don HOGAN Jr.** (W/M, DOB: 04/08/1972---48 years of age, 6'02", 225 lbs. Blue Eyes and Bald or Brown Hair) HOGAN is a Tier 2 Sex Offender convicted in LA of Oral Sexual Battery. LEO records indicate that the victim was a 9 year old male. He also has a 2016 conviction in LA for FTR as a Sex Offender. HOGAN is wanted by the LA State Police on a 07/07/2020 felony warrant for FTR as a Sex Offender. HOGAN's last known address with the NOPD SOR Unit was 1130 Oretha Castle Haley Blvd. New Orleans, LA.
11. **Gerald James DOMINICK** (W/M, DOB: 09/27/1955—65 years of age, 6'01", 150 lbs. Brown Eyes and Brown Hair) DOMINICK is a Tier 3 Sex Offender convicted in LA in 1984 of Forcible Rape. LEO records indicate that the victim was a juvenile. He also has two prior FTR as a Sex Offender convictions in LA. DOMINICK is wanted by the LA State Police on a 07/02/2020 felony warrant for FTR as a Sex Offender. DOMINICK's last known address with the NOPD SOR Unit was 4500 S. Claiborne Ave. New Orleans, LA.
12. **Anfernee Devante STEELE** (AKA: "Phat", B/M, DOB: 06/19/1999---21 years of age, 6'04", 290-320 lbs. Brown Eyes and Black Hair) STEELE is wanted by the New Orleans Police

Department on a 10/06/2020 felony warrant for 2nd Degree Murder and 2nd Degree Cruelty to a Juvenile (Beating death of a 4 year old female child at a New Orleans Hotel). STEELE, who is from Houma, LA, is also currently on LA Probation with Thibodaux District LA Probation for a Firearm and Narcotics conviction.

13. **Clayton F. STONECYPHER III** (AKA: Clay STONECYPHER or Todd Zirkle, W/M, DOB: 09/01/1971—49 years of age, 6'00", 165 lbs. Hazel Eyes and Brown Hair) STONECYPHER is a Tier 3 Sex Offender convicted in LA in 2004 of Attempted Simple Rape. STONECYPHER is wanted by the New Orleans Police Department on 06/24/2020 felony warrant for FTR as a Sex Offender. He is also wanted by LA Probation and Parole on a June 2020 warrant for LA Probation violations based on a felony conviction for DWI 4th Offense. STONECYPHER's last known address with the NOPD SOR Unit was 7725 Cohn St. New Orleans, LA.
14. **Malcom J. RICHARDS Sr.** (B/M, DOB: 11/23/1987—32 years of age, 5'04", 150 lbs. Brown Eyes and Black Hair) RICHARDS is wanted by the New Orleans Police Department on a 08/25/2020 felony warrant for Second Degree Cruelty to a Juvenile (alleged Child Abuse on a 2 year old male victim).
15. **Andre OKeefe BROWN** (AKA: "Okie" Brown or Jerome Brown, B/M, DOB: 01/09/1956---64 years of age, 5'11", 186 lbs. Brown Eyes and Black or Bald Hair). BROWN is a Tier 3 Sex Offender convicted in LA in 1995 of Aggravated Incest. LEO records indicate that the victim was a 12 year old female. BROWN is wanted by LA State Police on a 06/04/2019 felony warrant for FTR as a Sex Offender. BROWN's last known address with the NOPD SOR Unit was 1130 Oretha Castle Haley Blvd. New Orleans, LA.
16. **Wayne WILLIAMS** (AKA: "Hopper", B/M, DOB: 07/13/1960—60 years of age, 5'10" 223 lbs. Brown Eyes and Gray Hair) WILLIAMS is a Tier 3 Sex Offender with a prior LA 1970s conviction for Forcible Rape and a 2008 LA conviction for Sexual Battery. WILLIAMS is wanted by the New Orleans Police Department on a 07/09/2020 felony warrant for FTR as a Sex Offender. WILLIAMS last known address with the NOPD SOR Unit was Loyola and Tulane Ave. New Orleans, LA.
17. **Bryant Vincento ANGELETTA** (AKA: "Red", B/M, DOB: 01/14/1964—56 years old, 5'07" 135 lbs. Brown Eyes and Black Hair) ANGELETTA is a Tier 3 Sex Offender and is wanted by the New Orleans Police Department for FTR as a Sex Offender and by LA Probation and Parole on a LA Probation Violation warrant. He has been a fugitive since 2001. ANGELETTA was convicted in 2001 of Aggravated Oral Sexual Battery on a female child and Indecent Behavior with Juveniles.
18. **Brandon Kelly NEVELS** (B/M, DOB: 10/12/1991—29 years of age, 5'05" 137 lbs., Brown Eyes and Black Hair). NEVELS is a Tier 1 Sex Offender convicted in LA in 2014 of Carnal Knowledge of a Juvenile. NEVELS is wanted by the New Orleans Police Department on a 07/31/2020 felony warrant for FTR as a Sex Offender. NEVEL's last known address with the NOPD SOR Unit was 2516 Leonidas St. New Orleans, LA.
19. **Quinton Lee ANTHONY** (AKA: "Big Nuke" or Quentin Anthony, B/M, DOB: 11/11/1981-38 years old or 10/10/1981, 6'02" 345 plus pounds) ANTHONY was convicted in Texas in 2010 of Indecency with Child/Contact. LEO records indicate that the victim was a 14 year old female. He is a Tier 3 Sex Offender. ANTHONY is currently wanted by the New Orleans Police Department on a 09/10/2016 felony FTR as a Sex Offender warrant. He has ties to FL, TX, and LA.
20. **Darnell Lonnel HARRIS** (AKA: Lonnel Harris, B/M, DOB: 02/10/1973—47 years of age, 5'09" 170 lbs. Brown Eyes and Bald). HARRIS is a Tier 1 Sex Offender convicted in LA in 2018 of Sexual Battery. HARRIS is wanted by the New Orleans Police Department on a 09/11/2020 felony

warrant for FTR as a Sex Offender. HARRIS' last known address with the NOPD SOR Unit was 843 Camp St. New Orleans, LA.

21. **Jerome JOHNSON** (B/M, DOB: 08/18/1970—50 years of age, 5'07" 160 lbs., Brown Eyes and Bald or Black Hair). JOHNSON is a Tier 3 Sex Offender convicted in 1997 in LA of Forcible Rape, Second Degree Kidnapping, and Aggravated Crimes Against Nature. JOHNSON is wanted by the New Orleans Police Department on a 06/22/2020 felony warrant for FTR as a Sex Offender. JOHNSON's last provided address with the NOPD SOR Unit was 3328 1st Street #1 New Orleans, LA.
22. **Kumar A. STEPHEN** (AKA: Kumar STEPHANS, B/M, DOB: 08/10/1987, 5'09" 200 lbs. Brown Eyes and Black Hair) . Tier 3 Sex Offender convicted in LA in 2012 of Simple Rape. STEPHEN/STEPHANS is wanted by the New Orleans Police Department on a 08/09/2020, felony warrant for FTR as a Sex Offender. STEPHEN/STEPHANS last provided address to the NOPD SOR Unit was 8016 Lady Gray Street New Orleans, LA.
23. **Fitzalbert Norman MCGLOSHEN** (B/M, DOB: 02/19/1982, 5'11", 165 lbs. Brown Eyes and Black Hair or Bald) MCGLOSHEN is a Tier 1 Sex Offender convicted in LA in 2018 of Carnal Knowledge of a Juvenile. He is wanted by the New Orleans Police Department on a 09/25/2020 felony warrant for FTR as a Sex Offender. MCGLOSHEN's last provided address to the NOPD SOR Unit was 7670 Morel Street New Orleans, LA.
24. **Elder PAZ** (AKA: Elder GIOVANNI-PAZ or Elder PAZ-PEREZ, W (H)/M, DOB: 10/28/1998 or 10/28/1988---21 years of age, 5'06" 140 lbs. Brown Eyes and Black Hair). PAZ is wanted by the Kenner, LA Police Department (KPD) for several felony warrants from September of 2020 related to open sex based offense charges of Sexual Battery on Children and the gang Rape of a Child in the Kenner area. He has ties to Honduras.
